# LABOUR MARKET TRENDS IN SPAIN AND PORTUGAL: A YEAR IN REVIEW

#### Spain: Recovery and challenges

In Spain, 2024 marked a year of recovery after the pandemic's economic strain. Spain's labour market witnessed a strong rebound, with unemployment rates decreasing to the lowest level in over a decade. According to the latest data, Spain's unemployment rate stands at approximately 12.5%, representing a significant decline from previous years, though it still lags behind the EU average. The country has seen a rise in temporary contracts, especially in sectors such as tourism, hospitality, and agriculture, which continue to recover post-pandemic.

The Spanish government has focused on improving labour policies by promoting digital transformation and green energy initiatives, with a strong push for more sustainable industries. These efforts are expected to drive long-term employment in renewable energy, digital services, and technology. However, challenges remain for younger workers and women, with a focus on reducing youth unemployment and improving job quality.

Additionally, the gig economy has continued to expand, with many individuals engaging in freelance or short-term employment, particularly in urban areas. While this offers flexibility, concerns about job security and working conditions persist.

### Portugal: Steady growth amid challenges

In Portugal, the labour market also showed signs of recovery, but at a more moderate pace compared to Spain. The unemployment rate in Portugal has been relatively stable, hovering around 6.5%, one of the lowest in Europe. This reflects strong demand for labour, particularly in sectors such as technology, tourism, and real estate. The tech sector, in particular, has seen significant growth, with a rising number of start-ups and international companies choosing Lisbon and Porto as hubs for innovation and development.

Portugal's government has implemented a range of measures to support employment, particularly for younger and older workers, who have traditionally faced higher unemployment rates. There has been a concerted effort to modernize education systems and improve vocational training to better align the workforce with the needs of an increasingly digital and automated economy.

The country has also benefited from an influx of foreign workers, particularly in Lisbon, as multinational companies look to take advantage of Portugal's attractive business environment, cost-effective labour, and strategic location. However, rising housing costs and inflation have put pressure on wages, and many workers are facing stagnant salary growth despite low unemployment.


### Looking Ahead: The Road to a resilient future
