Litigation in the Italian legal market

The data presented in the market overview highlights a practice that is structurally relevant, increasingly sophisticated, and closely aligned with the needs of medium and large enterprises, while still undergoing important transformation in terms of diversity and specialization.

A solid and structured practice

With 710 professionals active in litigation departments across the surveyed firms, the practice demonstrates considerable scale. This critical mass reflects not only the enduring volume of disputes in Italy—ranging from corporate conflicts and insolvencies to administrative and regulatory challenges—but also the growing complexity of proceedings, which increasingly require multidisciplinary expertise.

Litigation accounts for 27% of total firm revenues (excluding boutiques), confirming its role as one of the main revenue generators for full-service firms. This proportion signals that, despite the rise of transactional and advisory work, contentious matters remain central to client relationships and long-term profitability. In many firms, litigation also acts as a countercyclical stabilizer, particularly during periods of economic uncertainty.

The average revenue generated by litigation in the last fiscal year (78.21) further supports the conclusion that disputes are not merely ancillary activities but core business lines with significant financial impact.

Client base: Strong enterprise orientation

The distribution of litigation revenue by client size reveals a pronounced focus on the corporate market. Big enterprises account for 42% of litigation revenue, while medium-sized enterprises contribute 39%, and small enterprises 19%.

This breakdown suggests several structural characteristics of the Italian litigation landscape:

- 1. Complexity and value concentration.** Large companies are more likely to be involved in high-value, cross-border, or regulatory-intensive disputes. These matters demand sophisticated legal teams and justify higher billing structures.
- 2. Strength of the mid-market** The nearly equal weight of medium enterprises reflects the central role of Italy's mid-cap industrial fabric. Many of these companies operate internationally and face disputes in areas such as commercial contracts, insolvency, procurement, and energy.
- 3. Selective Exposure to SMEs.** The lower percentage of revenue from small enterprises indicates that high-end litigation practices



tend to focus on disputes requiring advanced specialization or significant economic stakes.

Overall, the data points to a litigation market that is firmly anchored in the enterprise segment, with particular strength in supporting medium and large corporate actors.

Areas of Expertise: A diversified and evolving portfolio

The breakdown of litigation revenue by practice area provides insight into market dynamics and emerging trends.

The leading area is Insolvency (16%), reflecting ongoing restructuring activity and the impact of economic cycles on corporate stability. The importance of insolvency litigation suggests sustained demand for expertise in restructuring proceedings, liability actions, and distressed transactions.

Traditional business disputes remain central:

- Corporate Litigation (10%)
- Commercial Litigation (10%)
- Finance Litigation (8%)

Together, these areas form the backbone of contentious corporate work, encompassing shareholder disputes, contractual conflicts, banking litigation, and enforcement actions.

Administrative litigation also plays a major role:

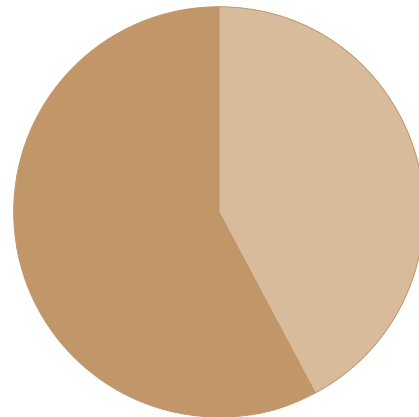
- Administrative Litigation – Energy (9%)
- Administrative Litigation – Procurement (8%)
- Administrative Litigation – Construction/Urban Planning/Environment (6%)
- Administrative Litigation – TLC (2%)

The combined weight of administrative matters underscores the regulatory density of the Italian economy. Energy and procurement disputes, in particular, reflect the strategic importance of public contracts, infrastructure development, and the energy transition.

Other notable segments include:

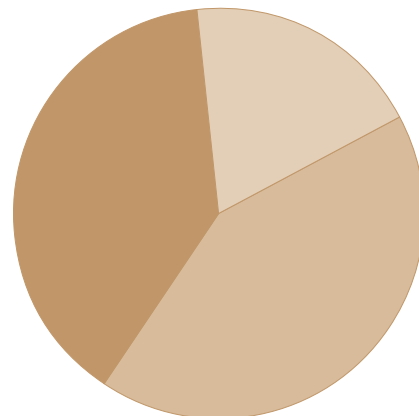
- Antitrust (6%), confirming the growing enforcement environment and competition-related litigation;
- National and International Arbitration (5% each), highlighting the increasing preference for alternative dispute resolution in both domestic and Insurance (4%), Product Liability (3%), Class Actions (3%), and Unfair Trade Practices (3%), which indicate steady, if more specialized, streams of work.

GENDER EQUALITY TOTAL TEAM



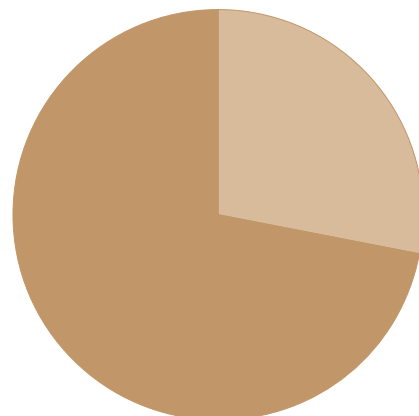

SIZE CLIENTS



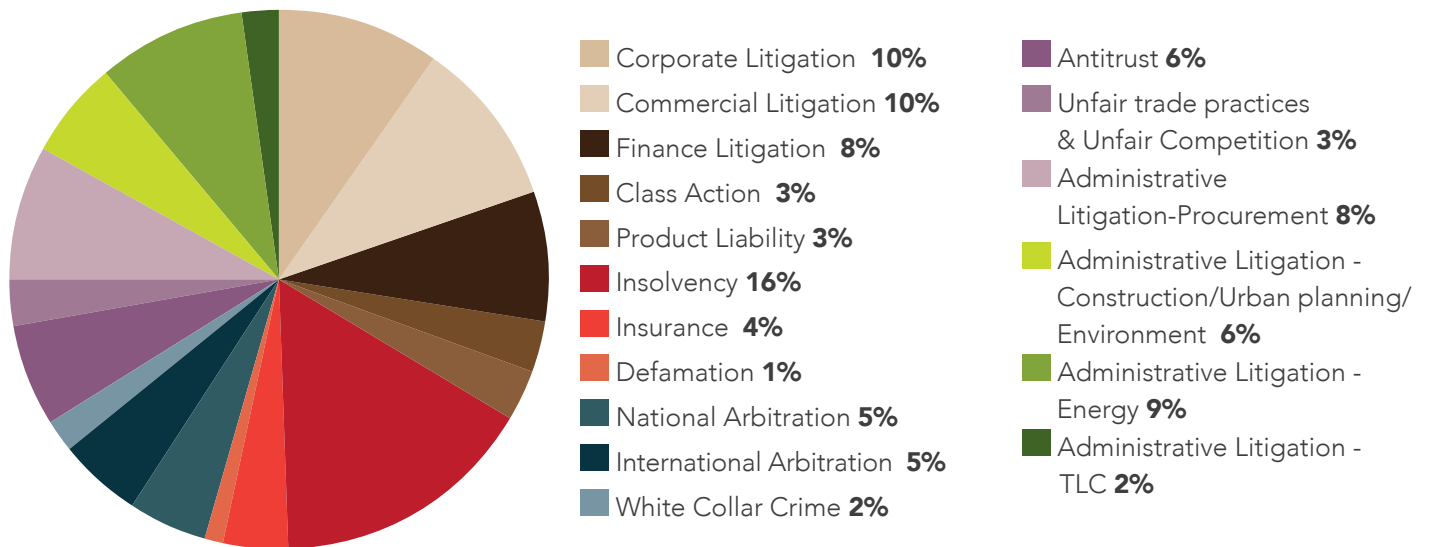

More niche areas such as White Collar Crime (2%) and Defamation (1%) complete a diversified portfolio that allows firms to respond to a wide spectrum of contentious needs.

Overall, the data portrays a litigation market that is both traditional—rooted in corporate and commercial disputes—and adaptive, with strong exposure to regulatory, energy, and restructuring-related matters.

Team structure and gender equality

The litigation workforce includes 299 female professionals, representing 42.11% of the total. This figure reflects substantial progress in gender representation at associate and counsel levels and suggests that the pipeline of female litigators is robust.

However, the picture changes at partnership level. Out of 123 partners, only 34 are women, corresponding to 27.64%. While this proportion is not negligible and indicates meaningful advancement compared to historical standards, it also reveals a persistent gap in access to leadership positions.

The difference between 42% female representation overall and 27.6% at partner level suggests that retention, promotion pathways, and leadership opportunities remain key challenges. For firms operating in a competitive and internationalized market, closing this gap will not only be a matter of equity but also of strategic positioning, talent attraction, and client

expectations—particularly as ESG and diversity metrics gain relevance in procurement and panel selection processes.

Strategic outlook

The Italian litigation practice stands at the intersection of stability and transformation. Its structural relevance—demonstrated by its 27% share of firm revenues—confirms that disputes will continue to be a fundamental pillar of legal services.

At the same time, the prominence of insolvency, energy, procurement, and antitrust litigation indicates that the market is responding to broader economic and regulatory shifts: corporate restructuring, public investment programs, infrastructure development, and heightened competition enforcement.

The strong reliance on medium and large enterprises further positions litigation teams as strategic partners rather than mere procedural advisors. High-value disputes often require integrated approaches combining litigation, regulatory insight, financial analysis, and cross-border coordination.

Finally, the evolution of team composition—particularly in terms of gender representation—will shape the next phase of development. Firms that succeed in translating strong female participation at associate level into more balanced leadership structures are likely to enhance both internal cohesion and external credibility.
